Additionally, I hereby agree to indemnify Releasees against and hold Releasees harmless from all damage, loss, claims, suits or action of any kind whatsoever, including attorney fees, which Releasees may sustain or incur, in whole or in part, as a consequence of the negligence or intentional misconduct in the the use of the Facility or the conduct of the above referenced Event and Facility.
- C. In further consideration of the City's agreement to allow use of the above referenced Facility, I hereby agree not to assert any claim against, sue, attach the property of, or prosecute Releasees for injury or damage alleged to have been caused in whole or in part by use of the Facility or the conduct of the Event at the Facility, or any other activity undertaken by me and/or my minor child, at or about the Facility with or without the City's permission, except due to the City's or Arts Council Santa Cruz County's gross negligence or willful misconduct.
- D. Should it become necessary to enforce the terms of this agreement by legal or equitable action or should I breach this agreement, I shall pay reasonable legal costs and attorney fees incurred by the City or Arts Council Santa Cruz County whether in defense of a suit by me or in the prosecution of a suit against me.

I, the undersigned, acknowledge that I have read the foregoing Agreement to Release, Indemnify, and Hold the City of Santa Cruz and Arts Council Santa Cruz County Harmless, have been advised of the potential dangers incidental to engaging in the project activities, and I am fully aware of the legal consequences of signing this agreement.

As indicated by my initials, I hereby give the City of Santa Cruz and Arts Council Santa Cruz County the right to use photographs or videos taken of me and/or of my child while participating in the above activity for reproduction in any medium for purposes of advertising, trade, display, exhibition, or editorial use.
